TOWN OF ACTON OVERNIGHT CAMPING PERMIT

THE FOLLOWING REGULATIONS AND RESTRICTIONS APPLY TO ALL PERSONS WHO WISH TO CAMP AT CAMP ACTON:

- ◆ Persons using Camp Acton do so at their own risk and must observe any requirement made by Town of Acton staff.
- ◆ The town will not be responsible for lost or stolen property.
- ◆ No person while camping at Camp Acton shall carry on any business or commercial calling, or trade, sell or otherwise deal in commodities or merchandise of any description, or solicit patronage.
- ◆ Disorderly conduct and obscene or indecent language is prohibited.
- ◆ No person shall operate a motor scooter, motorized bicycle or mini-bike within the premises of Camp Acton.
- ◆ No person shall build a fire for any purpose, except in fire places provided for that purpose. Stoves using gasoline or other manufactured fuels, and charcoal grills may be used if permission to do so has been granted by the Acton Fire Department. Fires must be extinguished before leaving the area. **No fires or grills of any kind may be used on picnic tables.**
- ◆ Cutting, mutilating, removing or taking away of live trees, shrubs, flowers or wood is prohibited. Persons in violation will be prosecuted to the full extent of the law.
- ◆ No person shall remove or deface any sign, poster or other property or remove any barrier on roads within or enclosing the park. No person shall leave a car on any roadway, all vehicles shall be parked in the parking area.

The **Recreation Authority** reserves the right to eject any and all violators of any park regulations, without the refund of any fees or admissions paid, also to remove any person or persons or animals it feels are detrimental to the health and safety of others using the park.

1. The Town of Acton or its boards, commissions and committees, shall not be held responsible for injuries incurred by individuals caused by their own carelessness while camping on town-owned land.
2. Groups or individuals interested in camping on town-owned property must provide the following documentation to the Board of Selectmen for approval prior to the date of camping.
 - ◆ A list of all individuals planning to camp.
 - ◆ Persons wishing to have open fires must contact the Acton Fire Department within 48 hours prior to camping. Permission to have open fires is at the discretion of the Fire Department 264-9645. Campers must also notify the Acton Police Department at 978-264-9638 to notify them of camping activities.

- ◆ Absolutely no alcoholic beverages will be permitted on Town of Acton property.
- ◆ It is the responsibility of the campers to remove all garbage or other waste produced while camping on town-owned land.
- ◆ Each party is required to have a self-contained toilet while camping, or a camping permit will not be issued.
- ◆ Vehicles must be parked in the designated parking area, not at camp sites.
- ◆ Children under the age of 18 must be accompanied by an adult at all times when camping on town-owned property.

The Town of Acton reserves the right to issue camping permits on a first-come first-served basis. No preference will be given to local groups, Camp Acton is a site of equal access to all residents of the Commonwealth.
