1. Opening

Chair Yacouby opened the meeting at 7:40 PM

2. Regular Business

A. Citizens' Concerns – None

B. Review and Approval of Meeting Minutes- The meeting minutes from the CPC's February 21, 2019 meeting were reviewed and approved: Motion to accept minutes by A. Green, seconded by W. Foster, approved unanimously.

3. Special Business

C. Project Deliberations: Asa Parlin House, S. Trimble asked if the project had substantially changed? J. Mangiaratti explained new scope of demolition and reviewed the latest submittal. J. Mangiaratti has made an application to HDC for selective demolition. W. Foster and S. Trimble moved their allocations for Asa Parlin to \$175K. S. Trimble moved his allocation for Mill Place to \$40K. Allocations firmed up. Question, what to do with left over \$14K. W. Foster opined that we leave it unallocated.

D. Finalize Funding Recommendations Foster moved that the Historic Resources set aside be applied to Iron Work Farm window project, and that Community Housing set aside be applied to Community Housing Fund. Second by W. Alesbury, unanimous. Motion by D. Charter to finalize the allocations as discussed and bring them forward to Town Meeting, seconded by W. Foster, approved unanimously.

E. Finalize Town Meeting Warrant Article R. Bartl walked through the draft Warrant. W. Foster moved to approve, W. Alesbury second, unanimous. Final edits as discussed to be provided by staff.

- F. Discussion of Historic Preservation Restriction: Town cannot seize the property if it is not maintained. Town would need to go to court to get relief.
