*Mark Gallagher for a project at 5 Fletcher Court and 74 Main Street (town atlas plate H3-B, parcels 27 & 43).*

**7:15 Notice of Intent: 106 Stow Street**

*Cintia Andrade for a project at 106 Stow Street, Acton, MA (town atlas plate H2, parcel 70). The project is the installation of a new septic system. Some work will occur within 100 feet of wetlands.*
