STREET ACCEPTANCE

The Board agreed to review Robert Road at the Fairway Heights II subdivision for Town acceptance. Mrs. Bayne and Mr. Weare will inspect the site and report back to the Board at the March 9, 1981 meeting.

ENDORSEMENT-WAMPANOAG HILL SUBDIVISION PLAN

The Planning Board reviewed the revised covenant for the Wampanoag Hill definitive subdivision plan and voted to endorse the covenant and plans as read.

LOT RELEASES

The Board voted to release Lot 20A, Beverly Road at the Acton Manor subdivision from the requirements of the the restrictive agreement dated January 9, 1958.

Mr. Dufresne informed the Planning Board that the Assistant Town Engineer has submitted a bond figure in the amount of \$60,000 for the completion of Nagog Park Road. The Board voted to approve the bond figure, and will release lot 101-E at Nagog Park after the Board receives a receipt that the bond has been posted.

Mr. Phillips presented his comments to the Board on site plan #1/21/81-201, Chaisson Realty. The Board voted to approve Mr. Phillips' comments which will be sent to the Selectmen with minor modifications.


MOVED by Mrs. Bayne, second by Mr. Bucklan, all in favor.
