MINUTES
CONSERVATION COMMISSION MEETING
JUNE 1, 1983 D.P.W. BUILDING

CALL TO ORDER: 8:10 P.M.

COMMISSIONERS PRESENT: Brewster Conant, Michael Graesser, Thomas Taylor, Dana Sawyer, and Judy Clark.

ALSO PRESENT: Julie Lipton, Conservation Assistant; Lawrence Nichols; and Richard Prince.

ITEM #1: Finances

The following bills were approved for payment by the Commission

ITEM #2: Powder Mill Plaza - State Properties

On the motion of Judy Clark, seconded by Dana Sawyer, it was unanimously voted to amend the existing Order of Conditions to include Plan Dated March 11, 1980 and revised April 27, 1983.

ITEM #3: W. R. Grace

Thomas Taylor said that he would write a letter to W.R. Grace officials reminding them that the Conservation Commission has jurisdiction under the State Wetland Law and the Acton Town Bylaw.

ITEM #4: Herbicide Spraying

Mr. Taylor said that he wrote a letter to Railroad officials informing them that the Wetland Bylaw has greater jurisdiction than the State Wetland Act and asked that a Determination of Applicability be filed.

ITEM #5: Lot 13A Jackson Drive

The Commission asked the assistant to write a letter to Mr. Finneran of Lot 13A Jackson Drive asking him to attend the June 15, 1983 Conservation meeting at 8:30 P.M.

ITE #6: Parlin Park III Subdivision

On the motion of Michael Graesser, seconded by Judy Clark, it was unanimously boted to accept Areas F & G as Conservation Lands.

ITEM #7: Capizzi Nursery

It was noted that Mr. Capizzi has not removed fill material from the wetland or filed a Notice of Intent as specified in the Enforcement Order. It was decided to send another letter.

ITEM #8: License Agreement - "Route 2 Land"

The Commission reviewed the latest License Agreement Draft (Dated June 1, 1983). It was decided to send a copy of the draft to the State. The Commission decided that the final draft will not be signed without consulting with Nancy Banks.

ITEM #9: Minutes

On the motion of Thomas Taylor, seconded by Brewster, it was unanimously voted to accept the Minutes dated April 27, 1983.

On the motion of Judy Clark, seconded by Michael Graesser it was unanimously voted to accept the regular minutes of May 4, 1983 as amended.

On the motion of Michael Graesser, seconded by Judy Clark, it was unanimously voted to approve the Executive Session minutes of May 4, 1983.

ITEM #10: Heather Hill Road - Certificate of Compliance

Lots 4, 5, and 6 Heather Hill Road will be inspected by Douglas Halley.

ITEM #11: 196 Great Road - Certificate Request


Will be inspected by Doug Halley.
