MINUTES  
CONSERVATION COMMISSION MEETING  
MAY 11, 1983

CALL TO ORDER: 8:00 P.M.

COMMISSIONERS PRESENT: Brewster Conant, Cynthia Torkelsen, Michael Graesser.

ALSO PRESENT: Julie Lipton, Conservation Assistant; Lawrence Nichols of Mohegan Road; Armand Dufresne, Town Planner.

ITEM 1: Parcel A, Silver Hill Road

The Commission discussed Parcel A off of Parker Road and Silver Hill Road with Mr. Nichols.

ITEM 2: Land Acquisition

The Commission discussed a possible land acquisition with Armand Dufresne.

ITEM 3: Lot #13, Map 1-2 at the rear of Main Street

The Commission determined that the above lot has no value for Conservation purposes, and that perhaps the Recreation Department would be interested in it as a neighborhood tot lot.

ITEM 4: Filling at Capizzi Landscaping - 820 Main Street, Parcel 60

The Commission was advised that fill had been placed in a pond located at the southwest property corner and along the waterway running parallel to the south property line.

The Commission determined that the activity was in violation of the Town Wetland Bylaw and M.G.L. Ch. 131, s. 40. The assistant was asked to send an Enforcement Order to the owner. Cynthia Torkelsen signed the Order, with the understanding that it will be ratified at the next meeting.

ITEM 5: Filling at Acton Block Co., 816 Main Street - Parcel 59


The Commission noted that fill has been placed in a wetland over a period of years. There appeared to be a small amount of new fill placed over the existing gravel. The assistant was asked to notify the owner of the site advising him that if he wishes to do work within 100' of a wetland he should file a Determination of Applicability Request or Notice of Intent with the Conservation Commission.

ITEM 6: Parking of motor vehicles on land adjacent to Issac Davis Trail at its intersection with John Swift Road.

Michael Graesser reported that on May 7, 1983 he received a complaint about parking trucks on land adjacent to Issac Davis Trail. It was decided to send a letter to Mr. Branon advising him that the property in question is not conservation land and that the letter is being referred to Don Johnson, Building Commissioner because of the zoning issue involved.
