C. Open Register Items Review

Verizon FiOS channel guide is still under investigation. Verizon is looking into it but we do not expect a quick resolution.

D. Other Activities

Acton TV was invited to give an update at this meeting. Mike Gowing and Marc Duci from Acton TV attended and provided an update. They informed CAC that they were busy with expanded Acton TV generated programming. Member programming and attendance has dropped a bit due to COVID. Acton TV had a short presentation of their programming. Acton TV is no longer using I-Net. We also discussed upcoming License renewals and future funding of Acton TV. CAC would like to thank Mike Gowing and Marc Duci for the update.



Char also provided an update on Comcast and Verizon License renewal. The end of useful life (EOUL) section of the I-Net agreement continues to be the final major sticking point in our license negotiation with Comcast. CAC does expect a resolution shortly and is negotiating with Comcast. The Town Attorney for Cable Affairs proposes that we proceed with the Verizon License negotiation after completing the Comcast one.
