7:15 Notice of Intent - 4 Agawam Road - D. Huszar (010, 011)

Ralph Romano from Global Engineering Consultants presented plans for the proposed removal and reconstruction of a portion of the existing house and replacement of the existing deck within 100' of a wetland. The existing foot print is 29' from the edge of wetlands; the proposed footprint will be 33' from wetlands and will 289 s.f. smaller than the existing and slightly further away from wetlands. The southeast portion of the house and garage will be demolished and reconstructed. Unsuitable soils will be removed and backfilled with more suitable material.

Upon query by Ms. Lee, Mr. Romano stated that all excavated materials will be removed from site via dumpsters and any new fill will be stockpiled outside of the 100' buffer zone then removed from the site.

Upon query by Mr. Froberg, Dennis Huszar (owner) stated that the new breezeway will have a full basement foundation with a walk-out to the back yard. Construction will occur in April or May, 2008.

Hearing no further comments or questions, Ms. Adachi closed the hearing.

Mr. Froberg moved that the Commission issue a standard Order of Conditions for the plans as presented; Ms. Lee 2nd, unanimous.
