This Special Town Meeting is called in accordance with Massachusetts General Laws Chapter 39, Section 10, which requires such assemblies upon the signed request of 200 or more petitioners (i.e., a Citizens' Petition). **It does not consider or supplant any articles scheduled for the May 6 Annual Town Meeting.** Both town meetings serve distinct purposes outlined by statute.

This Citizens' Petition, signed by 398 registered voters of the Town of Acton, was received on March 13. The statutory deadline to call the Special Town Meeting within 45 days falls approximately one week short of being able to include this Special Town Meeting within the already-scheduled Annual Town Meeting.
