Lisa spoke to Jeff Dugan of Mass Office on Disability(MOD), about having an ADA training session for Steve Ledoux. Jeff suggested that Acton host training for ADA coordinators. MOD generally recommends that the ADA coordinators training is more appropriate than

Community Access Monitor training. The COD agreed that Lisa speak to Steve about the possibility of this training.

Doug Halley – Acton Health Department – Discuss Acton Nursing Agency We want Acton citizens to get good quality care. Medicare keeps lowering the amount of money they reimburse. Patient load is being lowered. Some people are covered under insurance but not covered for homecare. We need take care of the people, but we have to be good to the people in Acton. We are having a group from Conn analyzing the Nursing Agency and giving a report to BOS by first meeting in August.

\$600,000 Acton budget for nursing service versus \$ 90,000,000 of total town budget (including schools)

We need to get better at letting Acton citizens know about the nursing service
