7:15 Request for Determination: 148 Great Road

(Continued from the meeting of April 19)

Scott Hayes, principle of Foresite Engineering, represented the applicant, Acton-Concord Chabad. He asked about the Commission's site visit. Mr. Maitland said that, based on the Commission's observations, they were in agreement with Mr. Hayes's assessment as presented at the prior meeting. Mr. Hayes reviewed the plan again and added that he hoped the Commission would issue a determination that would avoid having to file a Notice of Intent. There is construction behind the building for the Bruce Freeman Rail Trail. Wetlands are far enough away from the building to eliminate any impact. A lawn and a shrub border separate the building from the wetlands. There is a culvert as well as walking access to Route 2A on the property. It was again confirmed that the addition was to be constructed on sona tubes, not a full in-ground foundation. Mr. McKinnon recalled that the corner of the structure would be close to the 100 year flood-zone. Mr. Hayes said it was mapped in the survey, but the addition would be above the flood zone. Mr. McKinnon was satisfied with the response.

Decision: Mr. McKinnon moved to issue a negative three determination, that is work described in the Request is within the Buffer Zone, as defined in the regulations, but will not alter an Area subject to protection under the Act. Therefore, said work does not require the filing of a Notice of Intent. Mr. Colman seconded the motion and the motion passed with 4 ayes and one abstention.

7:30 Boston Gas, (d/b/a National Grid) Proposed Gas Main Relay Projects

The Commission reviewed a communication submitted to the Conservation Commission by National Grid outlining a project to upgrade the gas line between Spruce and Arlington Streets. This was received on April 11, 2017, shortly after a Request for Determination was submitted by Coneco Engineers and Scientists of Bridgewater, MA for a similar project on Newtown Road and Arlington Streets. The

Commission agreed that another filing wasn't necessary for this project. They requested that a response to the letter should be sent to National Grid with the request that the letter be reissued with a reference to Acton's bylaw and to affirm that this is a "repair and replace" project only.

Certificate of Compliance: 102 Windsor Avenue, DEP #85-868

Decision: Ms. Green moved to issue a Certificate of Compliance for this project, Mr. Colman seconded the motion and it was approved unanimously.


