 access coordinator with responsibilities to approve building permit variances
 pertaining to compliance with ADA requirements. He reported a good working
 relationship with Acton Building Commissioner.
 - Mr. Danny Factor serves as a board director of Green Acton. He believes that he will be an asset to the Planning Board as it is important for the Planning Board members to understand sustainability
 - Mr. Danny Factor has attended Planning Board meetings previously.

Motion to forward Danny Factor's name to the Board of Selectmen for further consideration to appoint as a member of Planning Board. Motion passed unanimously (4 Yes).



B. Hearing on Application by Sukhjinder Bajwa for Planning Board Membership

- Mr. Sukhjinder Bajwa is an Acton resident. He is a retired engineer.
- Mr. Sukhjinder Bajwa served as Building Chair for a Sikh Temple built in Westborough, MA. Throughout the project, he had extensive interactions with town of Westborough on building permit process.
- Mr. Sukhjinder Bajwa previously attended Planning Board meetings and had extensive interactions with town of Acton planning department. He felt that he can contribute to a stronger Planning Board.

Motion to forward Sukhjinder Bajwa's name to the Board of Selectmen for further consideration to appoint as a member of Planning Board. Motion passed unanimously (4 Yes).
