#### C. Open Register Items Review

1. Response to citizen concern from George Caplan is still outstanding. Ms. Simone will write up a response to Mr. Caplan.
2. In the August 2020 meeting the committee noted that when Acton TV cannot play a live committee meeting, they replay previously held committee meeting at the same time. During the replay there is no indication that this meeting was held at the previous date which could confuse town's citizens. Ms. Cooney has prepared a letter to be sent to Acton TV which Mr. Volinsky will forward to Acton TV.

#### D. Other Activities

1. Mr Volinsky updated the committee regarding the license negotiations between Acton representatives and Comcast. Town counsel for Cable Affairs will be providing an updated draft of the Cable license by October 6, 2020.
2. Committee representatives met with Comcast along with Acton IT and Acton TV to discuss I-Net distances. The I-Net distance was determined to be 19 miles which is down from the original 35 miles. Comcast is expected to provide the finalized information regarding I-Net configuration.



3. Committee requested that the next draft of the Cable license agreement highlight changes over previous drafts and previous agreements. Also, the committee is looking for a feedback from the town counsel in Cable Affairs regarding whether previously raised requests have been addressed.
4. Committee plans on meeting with Comcast representative at a future meeting, Plan to ask her about PEG HD channels at that meeting.

At 8.03 PM, it was moved by Mr. Volinsky and seconded by Ms. Simone to adjourn the meeting. The motion was approved unanimously.
