7:30 Request for Determination: 37 Mohegan Road
Applicant Curtis Warrington for a project at 37 Mohegan Road, town atlas plate no. D2, parcel 133-1. The project is the construction of an in-ground pool, patio and pergola, within 100 feet of wetlands.

7:45 Notice of Intent: Harris St Sidewalk
Applicant is the Town of Acton Department of Public Works for a proposed project for the construction of a sidewalk along the northern shoulder of Harris Street between Alexandra Way and Main Street. Portions of the sidewalk are within the 100 foot wetlands buffer zone.
