## **Renting a Garden Plot:**

1. Community Garden plot costs:
  - a. \$60 per plot per year for Acton residents.
  - b. \$80 per plot per year for non-residents.
2. Plot sizes:
  - a. Hebert: approximately 20' x 20
  - b. Morrison: are approximately 12' x 25' for small plots, 25' x 33' for large plots
  - c. North Acton: approximately 50' x 33' (full plot) and 25' x 33' (half plot).
3. Payment is by check, cash, or money order only. Credit cards cannot be accepted at this time. Make check payable to "Town of Acton." Garden plot fees are non-refundable.
  - a. **In person - Please drop off checks, cash, or money order to Acton  
Department of Public Works, 14 Forest Road, Acton, MA 01720**
4. Due to high demand, there is a limit of one plot per household/address.
5. Please note that current gardeners provide contact information for renewal mailing at time of registration. The town is not responsible for misdirected or non-receipt of garden renewal notices.
6. If you rent a plot and then are unable to garden, please notify Community Garden Coordinator so that your unused plot can be reassigned. Gardens left unused or unattended are subject to non-renewal.
