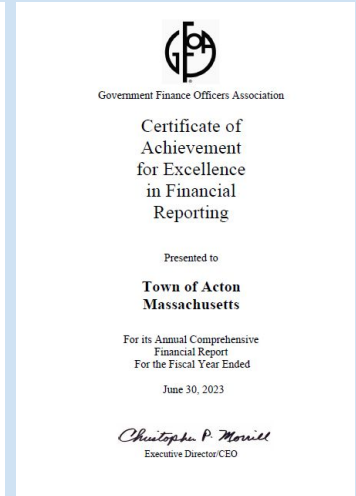
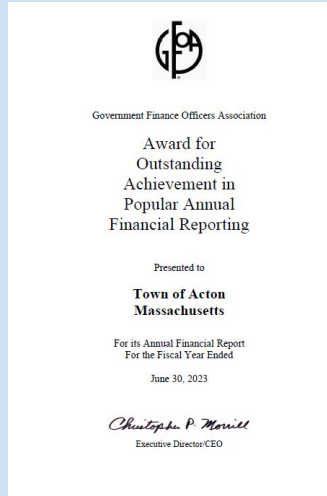

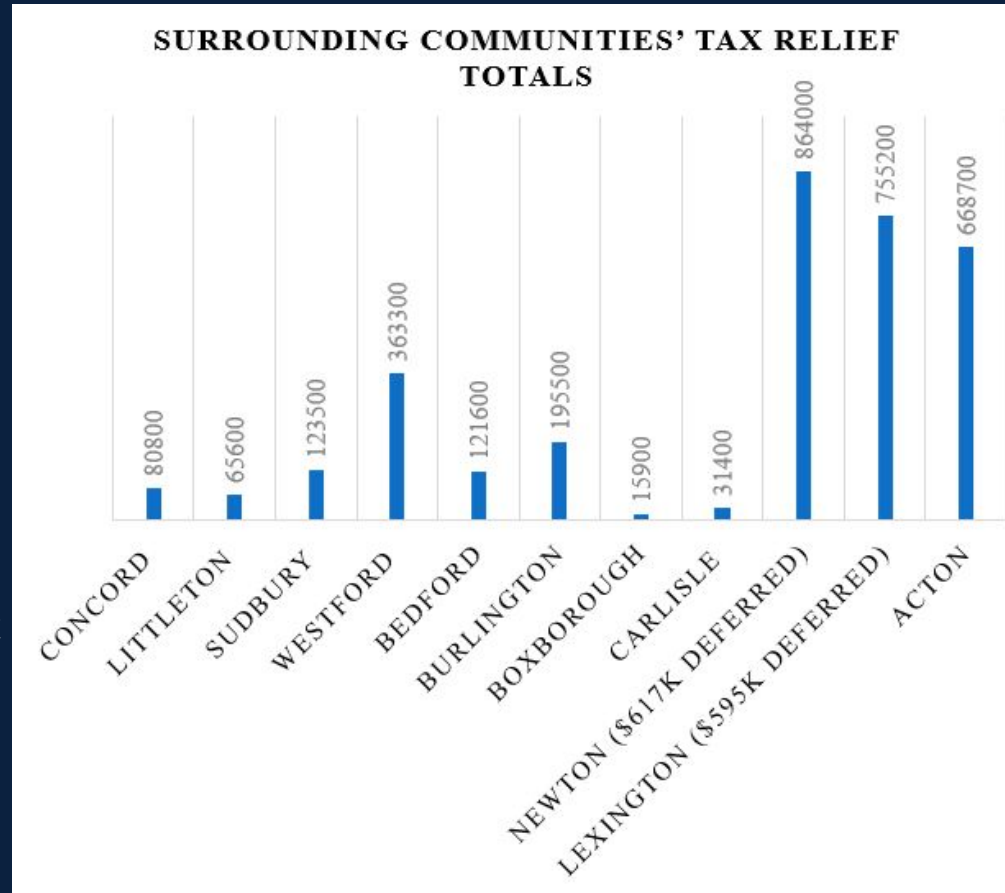
Grant Update

- \$3.9 million of grant dollars spent in FY25 from 53 separate grants
 - More than \$15 M received from competitive grants in the last 5 years
- Sewer Extension for McManus Manor: \$2,300,000
 - Federal Earmark for 17 Woodbury: \$750,000
 - LAND Grant for Wetherbee Land: \$500,000
 - HVAC Units for ABRSD: \$500,000
 - Cemetery Chapel ADA Improvements: \$250,000
 - Stanton Foundation \$250,000 for Dog Park
 - Minuteman Regional Bike Share: \$187,450
 - IT Community Compact Grant: \$114,563
 - Health Assessment and Equity Audit: \$90,000
 - Fire Department Study: \$57,500



Tax Relief

- In FY25 Acton provided \$668,700 in tax relief through exemptions to over 250 households
- A variety of programs are available for those in need of assistance:
 - Low income seniors
 - Disabled veterans
 - Surviving spouses of veterans/first responders
 - Blind individuals
 - Those in positions of medical and/or financial hardship.

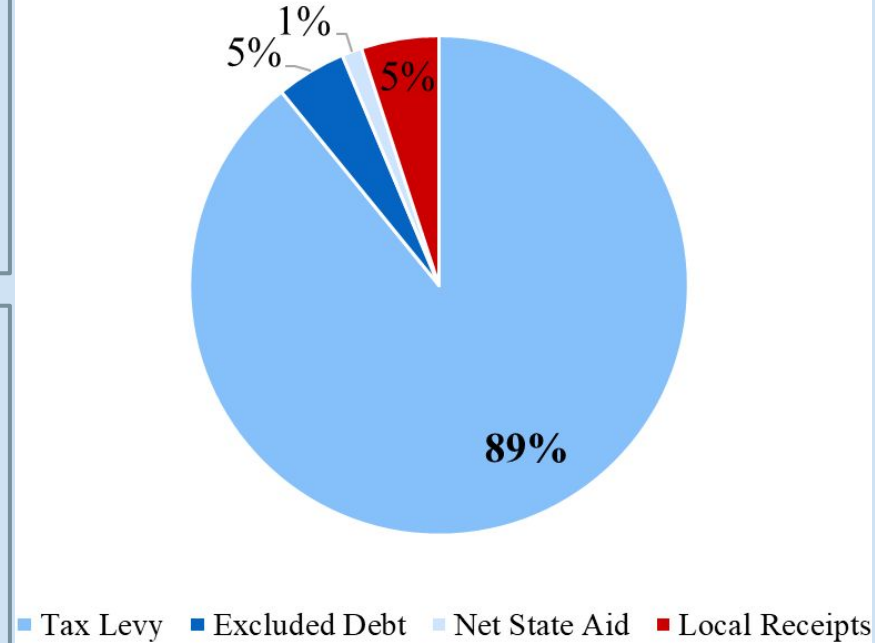

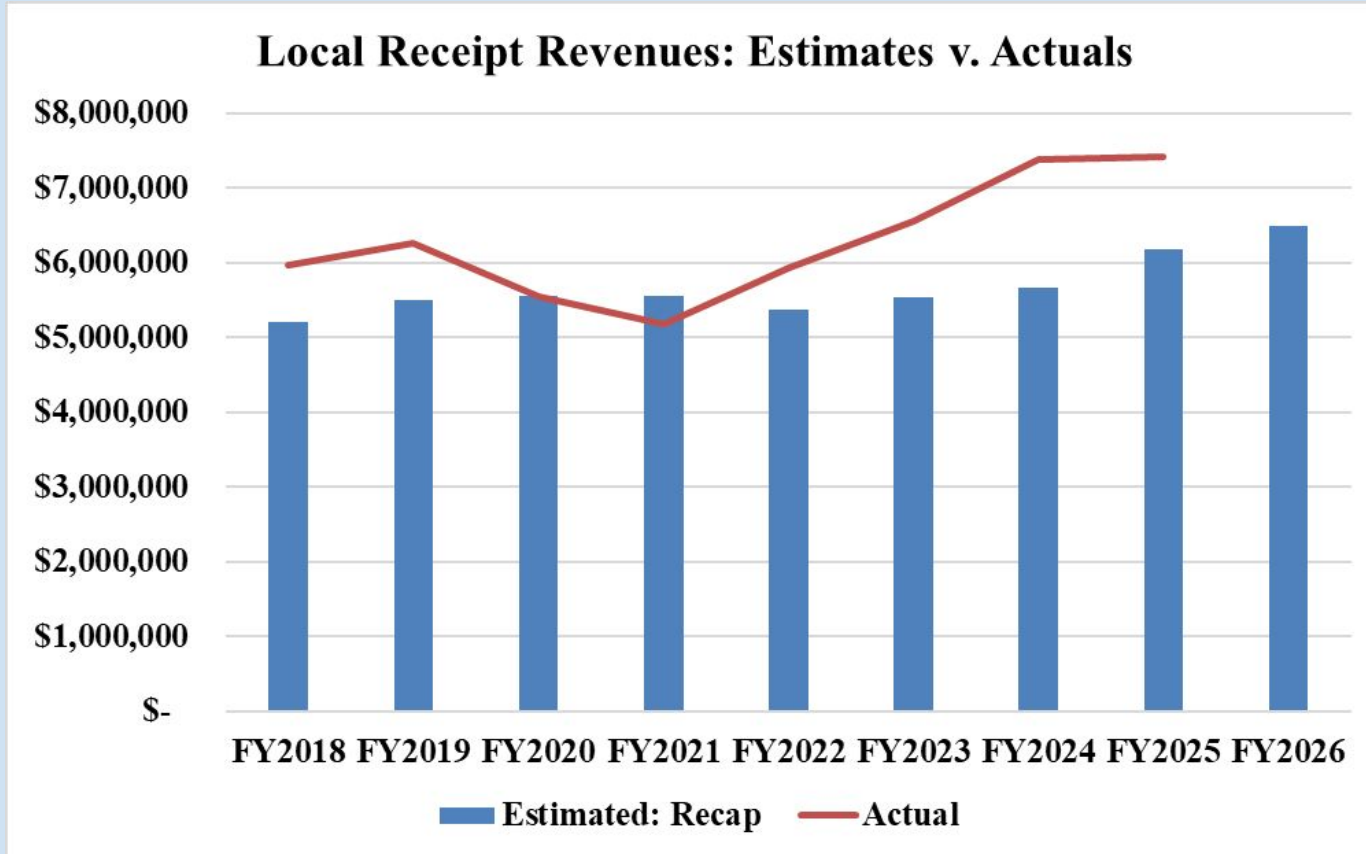

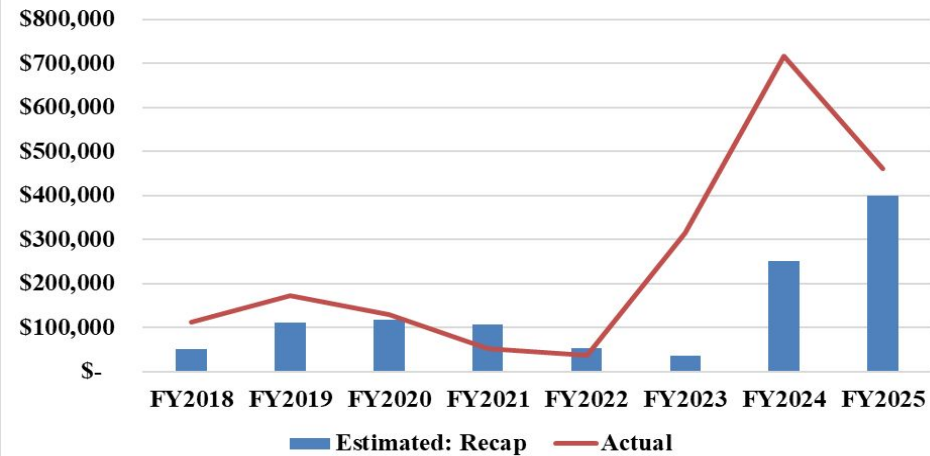
FY25 Preliminary Results: Revenues



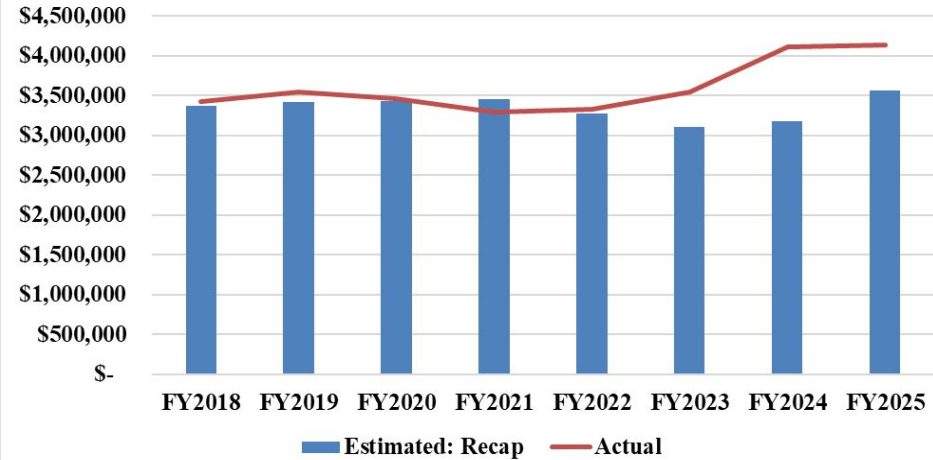

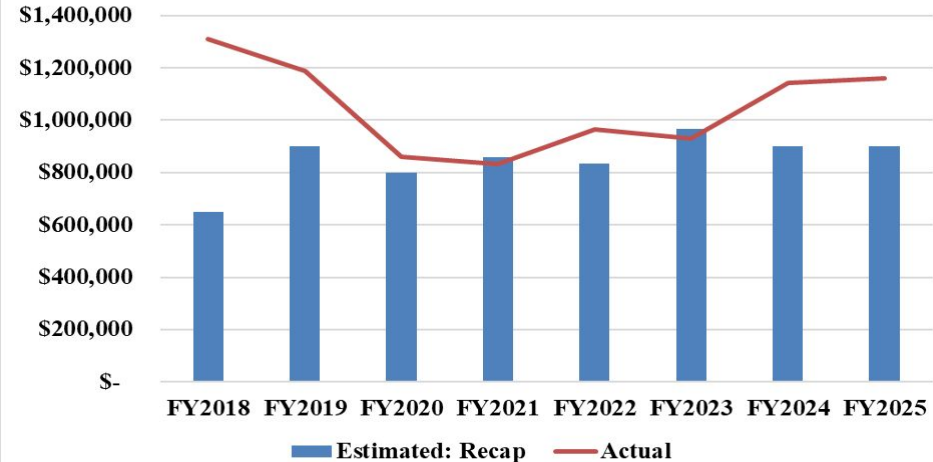
Net Investment Income: Estimates v. Actuals

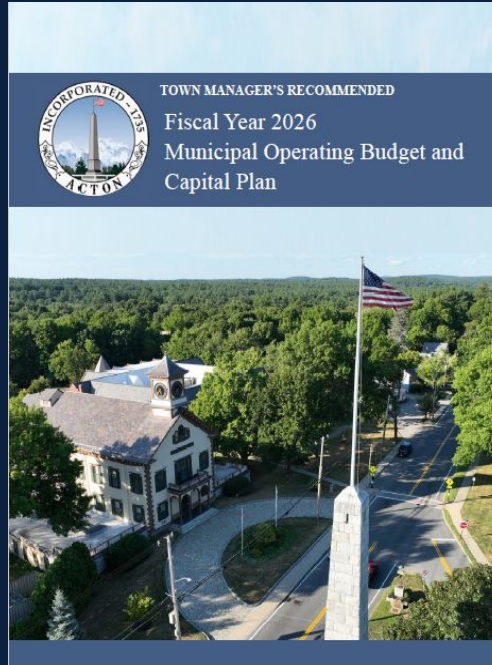
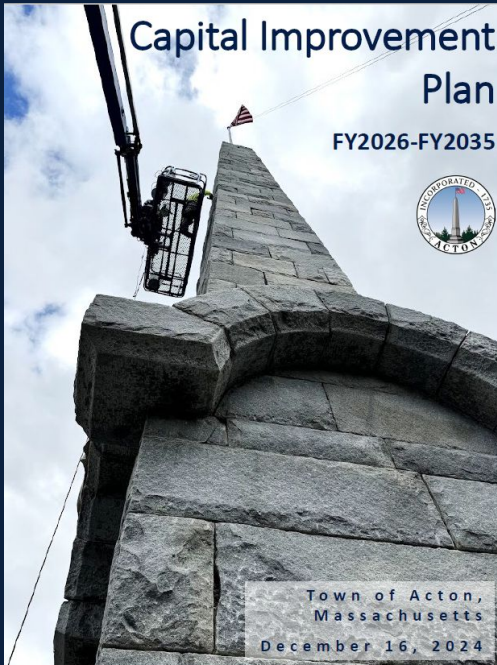

Select Board Goals

Short-Term Goals

- Finalize design and secure funding to complete Town Hall HVAC and Emergency Power Replacement Project and related building accessibility improvements
- Advance Town Meeting participation/access/education improvements, including early communication of warrant items to the public
- Create a communications position to improve community engagement
- Bring DPW facility project to Town Meeting. Work with Finance Committee and other Town committees to move project forward
- Complete study and begin implementation of Fire/EMS deployment and staffing study, including a capital plan for fire station upgrades or replacement

Long-Term Goals

- Explore additional tax relief programs for low income taxpayers
- Start a yearly Porchfest Concert Series for West Acton
- Continue Main Street intersection and complete streets improvements, i.e. Hayward, plus Central, High, Maple, Nylander, Railroad, School
- Work with Volunteer Coordinating Committee to create a plan for the future of volunteer recruitment and onboarding that includes improved orientation and streamlined appointment process
- Advance efforts to establish a public art plan and initiatives that utilize the arts to improve outcomes for economic development and public health
- Approve the final Stormwater Infrastructure Plan and begin implementation
- Facilitate low-income Community Solar and research the potential of including this option as part of a lower tier in the Acton Power Choice program
- Research and develop a proactive strategy for gas line replacement, repair, and non-pipeline alternatives

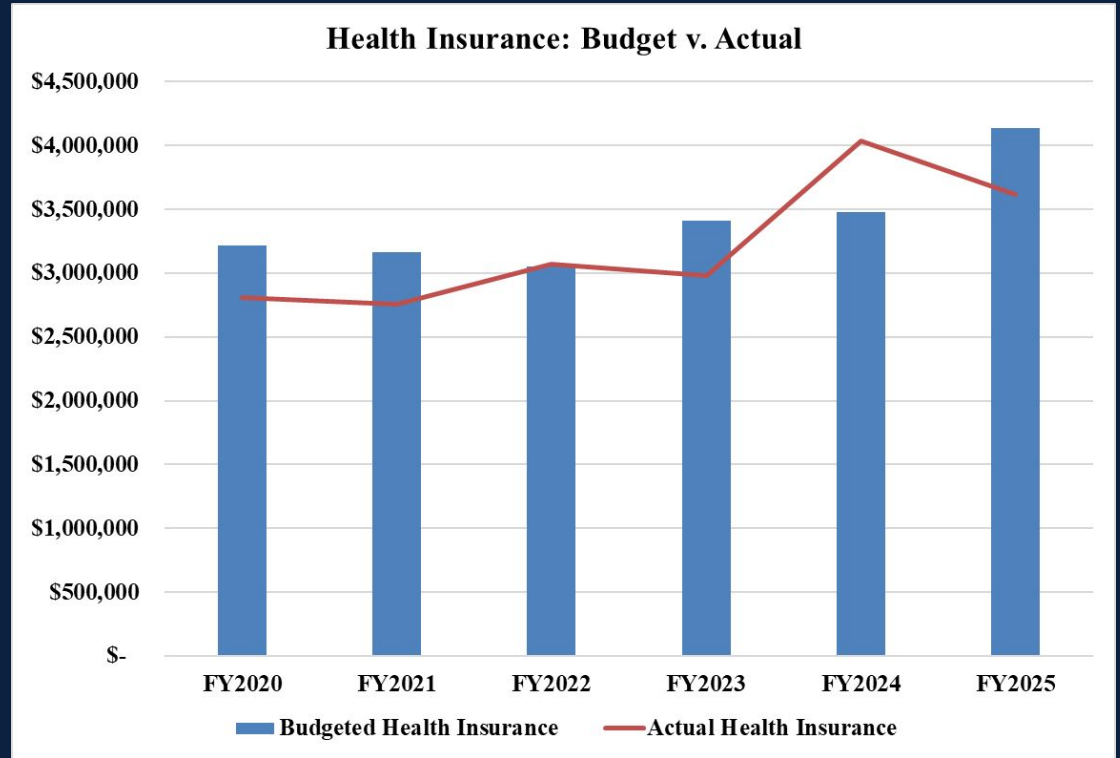

FY2027 Preliminary Budget Challenges

1. Health Insurance

- Finance Director's FY2026 Health Insurance budget is 54% higher than it was in FY2022
- MIIA estimates another 15% premium increase in FY2027 which would amount to **\$705k**

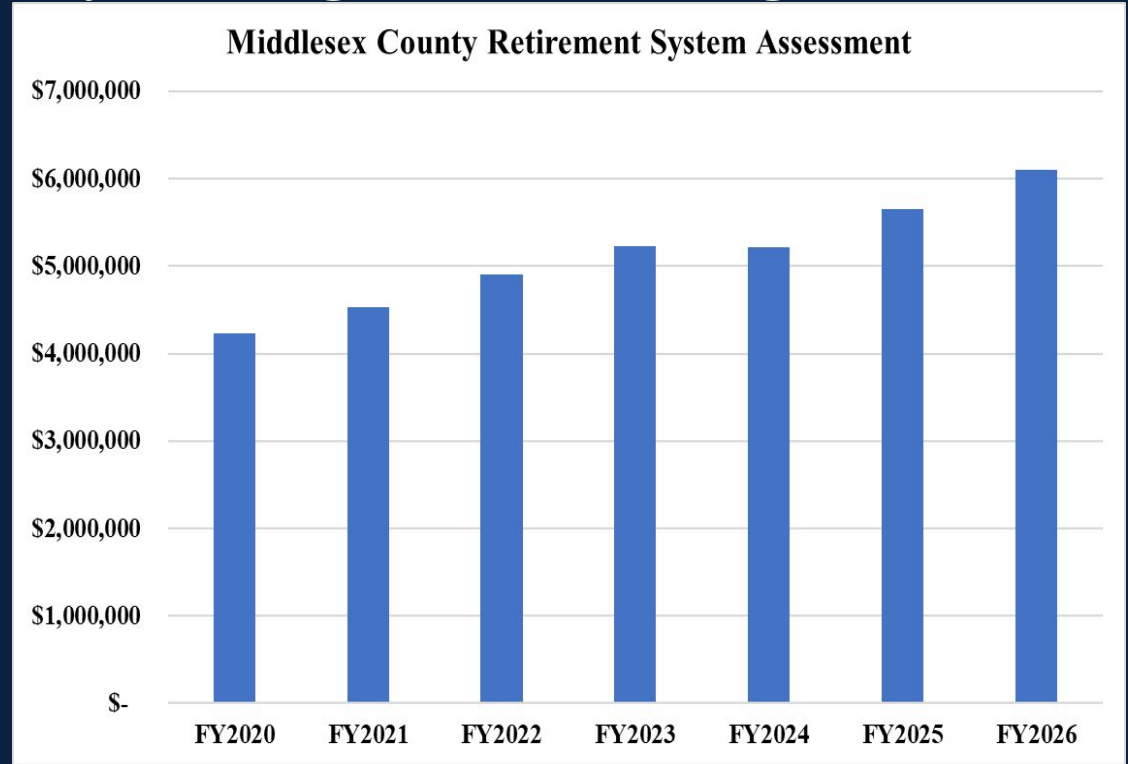


- Further analysis needed to determine available budget capacity in FY2027

FY2027 Preliminary Budget Challenges

2. Pension

- Average annual increase of 6.33% since FY2020
 - FY25: 8.41% increase
 - FY26: 7.81% increase
- A 6.33% increase would amount to **\$386k**

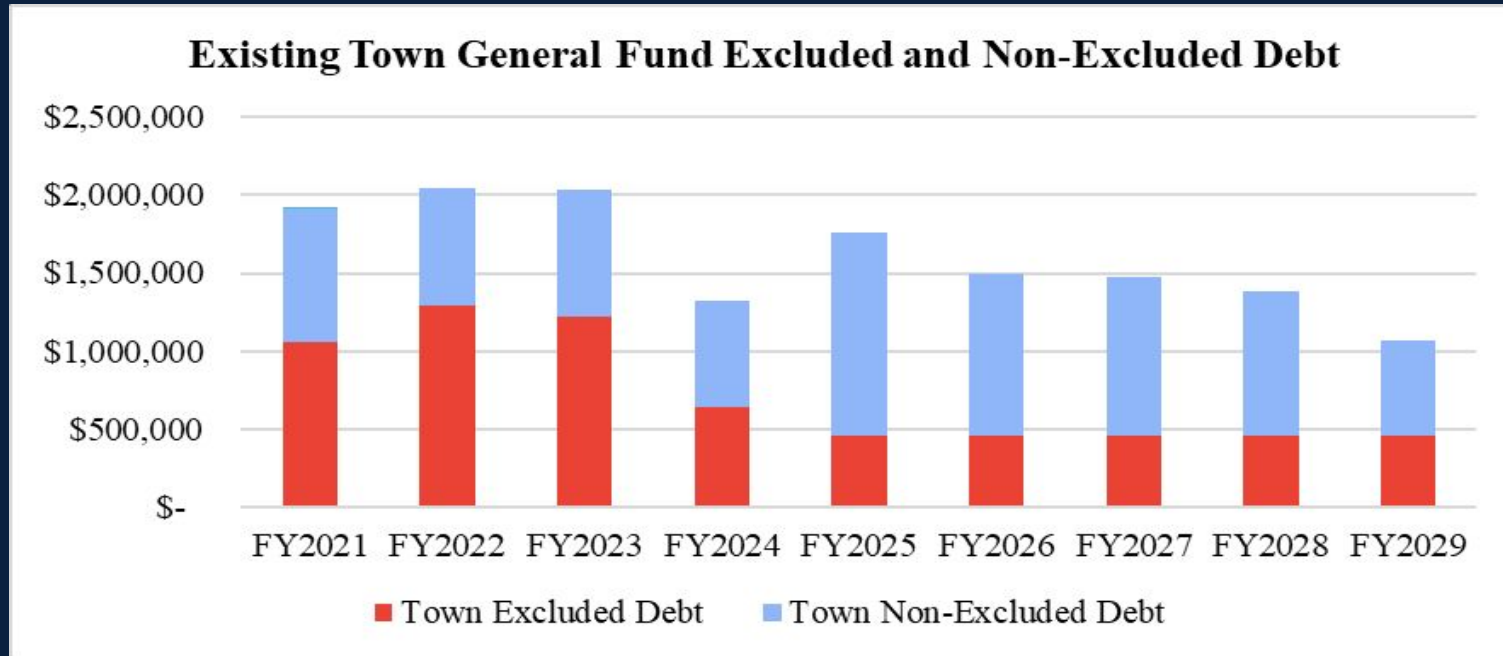


- As of 6/30/2024 valuation, Middlesex County Retirement System should be fully funded by June 30, 2036.

FY2027 Preliminary Budget Challenges

3. Debt

FY2027 Preliminary Budget Challenges

3. Debt

- The debt service related to DPW Fueling Station, Complete Streets, and Stormwater Infrastructure Improvements projects approved at the 2024 Annual Town Meeting will impact the Finance Director budget in FY2027— **an increase of \$417k.**

FY2027 Preliminary Budget Challenges

3. Debt

Fall 2023

FY2025 CIP Requests submitted by Department Heads

May 2024

Projects brought before Annual Town Meeting for approval by voters. Free cash appropriated to cover borrowing costs and first year's debt service.

May 2025

Borrowing for Complete Streets, Stormwater Infrastructure, DPW Fueling Depot, and Wetherbee purchase (CPA funded)

FY2026

First debt year's service paid from funding appropriated at 2024 Annual Town Meeting

FY2027

Finance Director's Debt budget is adjusted to accommodate new debt service payments

FY2027 Preliminary Budget Challenges

4. School Assessments

- During last year's ALG process, School Committee members forecasted an annual ABRSD assessment increase of 5-6% for the foreseeable future. Since increases in available revenues are limited, this will have an impact on the Town's budget.

FY2027 Preliminary Budget Challenges

5. Infrastructure Needs

- The FY2026-FY2035 Capital Improvement Plan identified \$111.738 million in needed investments in the community



FY27 Recommended Draft Budget Priorities

- OPEB appropriation:
 - Increase flexibility and update how OPEB Offset is appropriated so that it is separate from the municipal operating budget
- Focus on previously approved capital
 - Focus on existing capital appropriations and completing ongoing projects, rather than submitting new capital project requests
- Replenish Stabilization
 - Contribute funding to bolster the stabilization fund and increase the amount of funding available for future capital needs

FY27 Recommended Draft Guidance to Departments

- Continue to identify efficiencies through reorganizations
- Leverage External Funds
 - Continue to seek out and take advantage of alternative funding sources such as grants and earmarks
- Limit supply and service increases
